GROUND COVER: Broadcast at 3.8 lbs. per 1000 sq. ft. (20' x 50') of planting area.

SHRUBS & EVERGREENS: Sprinkle ½ cup evenly around dripline of plant and work into top 1 inch of soil.

TREES: Apply 1/2 lb. per 1 inch of trunk diameter. Distribute evenly under branches out to dripline.

NOTE: Liquid measuring cups are very close in estimating the weight of dry granular fertilizers. Example: An 8 oz. (1 cup) measuring cup holds approximately 8 oz. (1/2 lb.) of dry granular fertilizer.

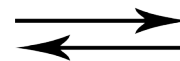
